Please apply with what product you would like to sell, and if possible, indicate an alternate product. Applications preferred by **August 10th**. Failure to apply by the August deadline may jeopardize your opportunity to market the product you endeavor to sell.

The Committee will decide on your application and notify you by August 24th.

**All vendors and crafters are responsible for cleanup of their areas and disposal of any garbage.**

Monday morning will feature the Annual Soap Box Derby as well as the 51<sup>st</sup> Annual Charlton Road Race. During the day, bands and singers will fill the air with music to entertain the guests. The finale of the day will include community awards for citizenship as well as the Grand Parade through Charlton Center.

### Guidelines

1. If you are preparing and selling food to the public you are required to complete a Board of Health Permit at the Town Hall before you sell on Labor Day. Please **DO NOT DELAY**.
2. Propane Permits required.
3. Sale of items is subject to committee approval. Be sure that you have been qualified for your item.
4. A liability insurance certificate is required for commercial vendors. Non-Profit organizations are excluded.
5. Vendors must provide their own tables, coverings, chairs, awnings (10' x 10' or 10' x 12')
6. The map of the booth layout is in PDF form and may be used as a 'guide only' as trees on the common have been removed affecting the exact layout. The map can be found at our web site:

7. No alcohol is permitted.
8. Raffles are permitted; obtain a permit at the Town Clerk's Office.
9. Vendors will be permitted to unload vehicles at the Common up until 8 a.m. Monday morning. No parking will be permitted on or around the Common. Parking is available at other locations.
10. Registration, on the Common in the Gazebo, starts on Sunday after 1 PM where you will pick up a Registration/Booth Assignment Form. Vendors are being assigned spaces by the committee.
