7:05	Brookfield Road – Map 15 B-4.2 – Iris Jennings Install a temporary intermittent stream crossing using timber pads for access for logging operations; Wetland restoration of a small area of wetland downgradient of intermittent stream crossing for silt that has been deposited.
7:10	Ben Axelman –Griffin Road - Map 27B-1, C1 Construction of a large scale ground-mounted solar field on approximately 10 acres of a larger lot, portions of which will be within the 100'buffer zone to on site wetlands. A recently constructed intermittent stream crossing (MassDEP file No. 128-1549) will serve as access. No wetland impacts under 310 CMR 10 is proposed and work is limited to buffer zones only.
7:15	4 Sturbridge Road, Map 27 Block B Lot 15 - Otis Land Management LLC. The site layout has been revised to incorporate a max build out of self-storage units, with the possibility of roof top solar. The total area of self-storage is 75,800 s.f. along with a 1,200 s.f. general office space with associated parking. The office will utilize a private well and septic system.
7:20	45 J Davis Road - Map 17 B-13 - Rockaway Realty Trust Construction of a roadway to serve as access for duplex units and single family units (16 units total).

8:00	Partridge Hill Road – Robin L Craver
	Construction to the Granite Lake/South Charlton Reservoir Dam including design improvements, repairs, pressure grouting, resurfacing, installations, mechanical cleaning, vegetation and debris removal.
8:05	Smith Rd., Stone Field Rd., Rock Meadow Rd. – White Development Corp
	Construction of a roadway system, utilities and associated grading occurring within 100ft. buffer of a bordering vegetated wetland to service 25 new residential lots. The project proposes to fill 4,130 sf of bordering vegetated wetland and provide 6,418 sf of replicated wetlands. Additionally 4,750 sf of isolated wetlands are proposed to be filled with 5,700 sf of replicated wetlands.
8:10	Brookfield Road – Michelle Garofalo
	Construct a solar farm, access driveway and electrical connections
8:15	107 Colburn Road – Brendan Gove
	Proposing to install a 2 megawatt solar photovoltaic facility and associated site appurtenances. Portions of the proposed activities are located within the 100-foot Buffer Zone to the Bordering Vegetated Wetlands but outside the 200-foot Riverfront Area associated an unnamed perennial stream. A small amount of activity (160+-sf) is located within the 100-year floodplain but results in no change to the flood storage capacity.
