The applicant has filed a Notice of Intent for the construction of a liquefied natural gas (“LNG”) facility and appurtenant features; comprised of the LNG facility located north of Rte. 169 at 190- 340 Southbridge Road, a gas interconnection in the Rte. 169 ROW from the LNG site to the TGP gas transmission main, and a gas Rd meter station (the connection point for the interconnection to the TGP main) at 190 Southbridge
 - b. 7:00 PM Cont. Notice of Intent (NOI) DEP # – 241 Sturbridge Road – Steven Goodman. The applicant has submitted a Notice of Intent for the construction of a 1.2 million square-foot warehouse structure, with associated access drive, loading docks, and parking areas. Associated site grading, retaining wall construction, stormwater

management, and utilities also are proposed. Portions of the proposed project will occur within Bordering Vegetated Wetlands (BVW) and within the 100- foot Buffer Zone to BVW. Erosion controls, stormwater management, and wetland replication are proposed. (Waiting for revisions)

(Waiting for revisions)
