By request, we are returning to Newfane, VT, for their 50th Annual Newfane Heritage Festival held on the common in the village near the congregational church. For 2021, they expect to have ninety or more juried arts, crafts and specialty products along with food and live music. We will have 90 minutes to browse the fair.

Turning back to the south, we are off to our included lunch at the New England House Restaurant in Brattleboro. Lunch will start with roasted butternut squash soup and entrée choice of maple apple sage pork loin glazed with maple applesauce, New England beef pot roast slow roasted with root vegetables and natural jus or slow-roasted turkey breast with giblet gravy and cranberry chutney. Also included are chef's choice of seasonal sides and freshly baked bread and butter, soft drink, coffee, iced tea, and tea. Dessert will be seasonal fruit cobbler.
